## **Additional Information**

The information below indicates additional information that the organisation included in their APCO Annual Report.

Describe initiatives, processes or practices that you have implemented during your chosen reporting period that have improved packaging sustainability

Our customer-facing packaging features Forest Stewardship Council (FSC Mix) certified shopping bags and boxes and 100% recycled polypropylene garment covers.

Our e-commerce team has introduced a second packaging option for customers purchasing online. Customers who wish to receive less packaging can opt for the Eco-packaging option, which uses fewer packaging components.

We use LDPE bags to protect our products during transport and storage. In the reporting period, we used 100% recycled LDPE for over 90% of the bags used and implemented a soft plastic recycling program in our stores and offices to ensure that LDPE bags are recovered and diverted from landfill.

Our hanger supplier continues to collect used hangers from our Australian stores to be cleaned and reused. Lastly, the outer canvas of our new eyewear cases is made of 60% recycled pre-consumer fibers (linen and cotton) and 40% virgin cotton.

Zimmermann's IP-sensitive fabrics from past seasons have been mechanically recycled and returned to their fiber state to be spun and woven into a canvas made of 60% recycled pre-consumer fibers (linen and cotton) and 40% virgin cotton. We chose to recycle IP-sensitive fabrics that carry distinctive prints and patterns and are typically unsuitable to reuse as-is. The recycled material was used as a key component of our new eyewear packaging.

- Actively participate in initiatives to promote packaging sustainability outside of our organisation.

#### Criteria 2:

#### Design & Procurement:

This criteria considers actions taken to ensure that sustainability principles are considered in the design or procurement of both new and existing packaging through use of the Sustainable Packaging Guidelines (SPGs).

- Review 91% of our packaging against the Sustainable Packaging Guidelines (or equivalent).
- Improve the accuracy of our data regarding reviews of packaging using the Sustainable Packaging Guidelines (or equivalent).
- Incorporate the Sustainable Packaging Guidelines (or equivalent) into procurement processes.
- Consider the following Sustainable Packaging Principles in our packaging reviews:
  - Design for recovery
  - Optimise material efficiency
  - Design to reduce product waste
  - Eliminate hazardous materials
  - Use of renewable materials
  - Use recycled materials
  - Design to minimise litter
  - Design for transport efficiency
  - Design for accessibility
  - Provide consumer information on environmental sustainability
- 31% of our packaging to be optimised for material efficiency.
- Improve the accuracy of our data regarding packaging material efficiency.

#### Criteria 3: Recycled Content:

This criteria considers actions taken to increase or optimise the amount of recycled material used by your organisation.

- Develop a policy or procedure to buy products and/or packaging made from recycled materials.
- Use recycled content in:
  - Our products
  - Primary packaging that we use to sell our products
  - Secondary packaging that we use to sell our products
  - Tertiary packaging that we use to sell our products
  - Other items which we purchase (e.g. office stationary and suppliers etc.)
  - 32% of our packaging to be made using some level of recycled material
- Improve the accuracy of our data regarding use of recycled materials.





#### Criteria 4:

#### Recoverability:

This criteria considers actions taken to improve the recovery of packaging at end-of-life and increase use of reusable packaging.

- 84% of our packaging to be designed to have all packaging components be recoverable at end-of-life.
- Improve the accuracy of our data regarding recoverability.
- Investigate opportunities to use reusable packaging.
- 14% of our packaging to have all packaging components that are reusable.
- Improve the accuracy of our data regarding reuse.
- Participate in a close-loop recovery program/alternative collection system.

### Criteria 5: Disposal Labelling:

This criteria considers the extent to which packaging has been labelled to help consumers determine what to do with packaging at end-of-life.

- 45% of our packaging to have on-pack labelling to inform correct disposal.
- Improve the accuracy of our data regarding labelling.

### Criteria 6:

#### **On-site Waste:**

This criteria considers progress in increasing the amount of on-site solid waste being diverted from landfill.

- Have recycling programs for the following materials:
  - Paper/cardboard
  - Soft plastics
  - Rigid plastics
  - Textiles
  - Glass
  - Metals
- Aim for 54% of our on-site waste to be diverted from landfill.
- Improve the accuracy of our data regarding on-site waste.

## Criteria 7: Problematic Materials:

This criteria considers the extent to which organisations are actively phasing out problematic and unnecessary single-use plastic packaging and preventing/reducing litter.

• Help reduce litter by:





- Circulated internal communication to promote recycling, increased the available recycling streams and updated the range of recycling bins available in our offices and their signage. We worked with departments stores in which Zimmermann stores are located to improve the available recycling streams.
- Phase-out the following problematic and unnecessary single-use plastic items:
  - Rigid polystyrene (PS) packaging
